Before paying the member his wages, you shall deduct the employee's contribution rund from his wages which together with your own contribution and administrative charges shall be paid within 15 days of the close of every month in the Accounts of the Fund maintained by the State Bank of India by separate challans in the following manner :-

- (a) E.P.F. contribution
- (b) Administrative charges
- (c) Family Pension

To be deposited in E.P.F. A/c. No. 1 To be deposited in E.P.F. A/c, No. 2

To be deposited in Employees, Family Pension A/c No. 10.

  - (ii) It may be noted that if timely deductions are not made from the member's wages, the employer will have to pay both the shares himself, as the recovery of arrear, contributions for the back period from the subsequent wages of the employee's is prohibited except when such recovery could not be made at the appropriate time due to accidental mistake or clerical error.
  - (Irr) The Family Pension Scheme will be applicable from prospective date i, e. the month of Issue of this coverage notice.
